






PRESIDENT'S MESSAGE

This past year saw some significant achievements for QC. Qikiqtaaluk Corporation (QC) is a 100 percent Inuit-owned birthright development corporation. QC was established in 1983 by its sole shareholder Qikiqtani Inuit Association (QIA). QC is the for-profit development arm of QIA. QC's goal to improve the social and economic well-being of Nunavut and the 15,500 Qikiqtani Inuit we represent by investing in and creating strategic business opportunities. To advance this goal, QC strives to be a major contributor to all sectors of the Nunavut economy.

MISSION:

To create meaningful economic, employment and career development opportunities for Inuit.

VISION:

Fostering economic development opportunities for Inuit. Since our creation, QC has matured into a multi-disciplinary company with 32 subsidiaries, joint ventures and affiliations. QC has eleven subsidiaries which are 100 percent owned by QC, four majority owned joint ventures, nine joint venture partnerships and eight affiliated companies. Through these companies, QC has strategically established business in the fisheries and marine service, property management and real estate, construction, fuel storage and distribution, transportation and communications, environmental service, retail and trade service, and the clean energy sector.

While fostering economic development opportunities for Inuit in the Qikiqtani region and throughout Nunavut, QC balances tradition with innovation. Through this approach QC seeks to improve both the social and economic well-being of Nunavut.





2018/19 HIGHLIGHTS

AQSARNIIT HOTEL AND CONFERENCE CENTRE

May was an exciting month for QC as construction of the Agsarniit Hotel and Conference Centre broke ground. Blasting of the foundation started in early May and the first pile was driven in June 2018. The construction crew made excellent progress, and by the end of the fiscal year the entire first floor was erected.

The hotel is designed with energy efficiency in mind. The envelope is highly energy efficient and the structure has been designed to accommodated future incorporation of renewable energy such as solar panels.

QC is using a non-conventional modular construction technique for the hotel tower. Stack Modular, a Bird Construction partnership, is custom-building the modular guest rooms and suites offsite. Fabrication of the modules commenced in 2018. The modules are anticipated to arrive in Igaluit in July 2019 and will be fully fitted with fixtures, furniture and finishings.





When in operation, the hotel will employ over 100 staff. QC will be offering training to Inuit across the region in the hospitality industry to fill many of these positions.

The hotel is on schedule to open its doors in April 2020.



Agsarniit Hotel and Conference Centre will be Nunavut's premier hotel featuring more than 90 guest rooms, including 12 suites, a 6,300 square foot conference center, an 80-seat restaurant and 186-seat lounge, and other amenities such as a fitness center.

ACQUISITION OF QIKIQTAALUK FISHERIES CORPORATION

In September 2018, QC announced its newly acquired 100 percent ownership of Qikiqtaaluk Fisheries Corporation (QFC). After purchasing shares from its minority partner, QC became the sole owner of QFC and its harvesting vessel the Saputi. QFC owns and operates the Saputi to fish QC's allocated shrimp and turbot quota.

Acquiring full ownership of QFC will bring many opportunities for QC. It will mean more training and employment opportunities for Inuit, more money staying within the Territory and an increase of returns which allows QC to diversify their operations therefore furthering benefits and opportunities to Qikiqtanmmuit.

SAPUTI FACTS:

The Saputi is a factory freezer vessel which harvests both shrimp and turbot in Nunavut's offshore adjacent fisheries. The Saputi crew varies from 26-29 members per trip, many of which are Inuit.







CLEAN ENERGY

The announcement of QC's new clean energy developer subsidiary company was highlighted in last year's Annual Report. Nunavut Nukkiksautiit Corporation (NNC) was created to pursue clean energy projects in the Qikiqtani region. This past fiscal year was the company's first full year of operation. The company focused on advancing several clean energy projects and is projected to have significant growth over the upcoming years.

MISSION:

To pursue a diverse portfolio of clean energy projects in the Qikiqtani region that will improve community capacity and self-reliance by creating opportunities that enhance local Inuit business and individual career development prospects while alleviating fossil fuel dependency.



The energy transition in Nunavut has been hindered by uneven approaches of governments and the utility sector. Over the past year, NNC has been actively involved in advocating for harmonizing these agencies to promote an independent power production program that prioritizes Inuit, is guided by the intent of the Nunavut Agreement and is transparent and equitable. NNC envisions a Regional-Community partnership model to advance clean energy projects in the communities. With limited resources and aging infrastructure, Nunavut communities often do not have the administrative, technical, or financial resources to independently lead large-scale renewable energy projects. A partnership with QC will ease the financial and capacity burdens of project implementation while still maintaining community ownership and leadership.

INUIT EMPLOYMENT

Qikiqtaaluk Corporation and Group of Companies prioritize Inuit hiring and are committed to capacity building through training and promotion within the company structure. All QC companies focus on developing Inuit leadership, expertise, and experience. Training programs are incorporated in major projects to increase Inuit involvement and promote Inuit employment in the project.



QC has 353 Inuit employees of 538 total employees. QPI continues to employ 100 percent Inuit staff and QRS and QIL both have a greater than 90 percent Inuit employment rate. With the addition of QFC to the wholly-owned subsidiaries, our overall percent Inuit employment has decreased. QC sees this as an opportunity: as we expand our company, we can offer a greater variety of employment opportunities for Inuit. We remain committed to promoting Inuit employment and training across all our companies and anticipate QFC Inuit employment rate will increase and be reflective of QC's continued commitment to Inuit employment.

EMPLOYEE GROWTH

QC Companies continue to see consistent growth. Thirty-five years ago, QC had a single employee. In 2005, the company grew to a 150+ employee operation and since then we have grown to over 530 employees.

To support QC and Group of Companies' growth and in response to acquiring 100 percent ownership of QFC, new positions were established. QC and QPI also created new positions to better serve clients and accommodate company growth and expansion.






QC and the QIA Board of Directors created and approved the Dividends Policy. Since its creation, QC has contributed over \$7.2 million in dividends to QIA.

The Nunavut Quest

The Nunavut Quest is a weeklong traditional dog sled race where competitors traverse an unforgiving sea of ice and tundra. In 2019, 12 dog sled teams raced from Pond Inlet to Arctic Bay, more than 300 km away. QC is proud to contribute to this annual race that highlights a traditional method of travelling for Inuit.

Nunavut Kamatsiaqtut Help Line

Nunavut Kamatsiaqtut Help Line provides anonymous and confidential telephone counselling to Nunavummiut in crisis. Kamatsiagtut was founded in 1989 responding to an increase in suicides. In 1990, donations supported the installation of a 800-toll free extension making the service free to anyone in need of 'a listening and non-judgmental ear'. People in crises and needing to talk are supported through this service. QC is appreciated of this service which helps to provide counselling services for Qikqitani Inuit. QC contributed to this volunteer-based service which operates three hundred and sixty-five days a year.

Toonik Tyme

Toonik Tyme is an exciting multiday event which started in 1965. QC was proud to be a Gold Level sponsor for this year's festivities. Events such as ptarmigan hunting and seal skinning contests, dog sled and snowmobile races, elder's craft fairs and a traditional Inuit clothing fashion show draw big crowds and promote our culture and heritage.

QC was a gold level sponsor of the 27th Annual Nunavut Trade Show and Conference. This is Canada's largest annual businessto-business event, and it brings together all levels of government, Inuit Corporations, Nunavut and southern businesses, investors and entrepreneurs. It provides participants the opportunity to network, learn from each other and develop strategic partnerships.

This year's conference theme was "Stronger Together". Harry Flaherty was invited to deliver a keynote luncheon address. Mr. Flaherty took the opportunity to speak about advancing economic infrastructure through partnerships with Inuit development corporations, collaboration and strategic investments. He also spoke about QC's current initiatives and the opportunities these projects will bring for Nunavummiut and Nunavut.

FISHERIES DIVISION **ACTIVITY REPORT**

The Fisheries Division of QC oversees all fishery and marine related activity interests of the Corporation. It represents QC on various fishery related Boards, Agencies and Associations and negotiates and advocates for fair and equitable allocations of fishing quota.

The Fisheries Division provides support to QC's wholly-owned Qikiqtaaluk Fisheries Corporation (QFC) and joint-venture Unaaq Fisheries Inc (UFI). The Division is responsible for managing and distributing QC's and 50 percent of UFI's fishing quota and allocations received through the Nunavut Wildlife Management Board's Access and Allocations process.

QC's focus is to maximize its harvest of turbot and shrimp on its 100 percent Inuit owned and operated multi-species factory freezer vessel the Saputi. Any quota the Saputi cannot harvest is transacted to other vessel operators. The Fisheries Divisions negotiates these transactions to ensures the benefits from the quotas are maximized for Nunavummiut.

Quotas for harvesting by QC's companies come from:

- quota received through the NWMB access and allocation process;
- its offshore shrimp license (1.5 of 17) issued by Department of Fisheries and Oceans: one is held in full by QC and one is equally shared with Makivik Corporation through UFI; and
- quota purchased from other Nunavut turbot and/or shrimp holders, and southern companies.



2018/19 Highlights

Involvement in NWMB's 2019 Access and Allocation Policy

Periodically, the Nunavut Wildlife Management Board (NWMB) revises its policy for access and allocations to Nunavut's adjacent fishing stock. In early 2019, NWMB released its revised Access and Allocation Policy. OC Fisheries Division was an active participant in the detailed revision process that occurred over a 2-year period, attending all stakeholder meetings, presenting directly to the Board and providing written input on the Policy and proposed changes.

OC strongly advocated for a more equitable share of Nunavut's adjacent turbot and shrimp allocations. Previously, QC only had 10.7 percent of turbot and 33.6 percent of shrimp allocations; the lowest share of any of the four Nunavut fisheries. QC lobbied that investment in the industry, percent Inuit employment, and commitment to reinvestment in Nunavut and the fisheries, should all be considered in the access and allocation decision making process.

QC is content with the updated policy and feels the overall objective of a fair, open and transparent process to determine access and allocations for Nunavut-based commercial fishers in adjacent Nunavut waters will be achieved. Completion of this revised policy will have significant positive consequences for QC and its future fishery operations.

Quota Negotiations

This past fiscal year, the Fisheries Division worked hard to advocate to the Nunavut allocation holders that the turbot quotas were not distributed equitably and in particular, that QC, at only 10.7 percent, was not receiving a fair share of the overall turbot quota. QC negotiated with the other Nunavut allocation holders to correct this. QC entered into an agreement with these holders which states QC would be provided access to harvest 70 percent of the most recent 1933 ton increase in 0A/0B turbot allocations over the next two years. QC will now harvest a minimum 19 percent of the overall Nunavut turbot allocations in 2019 and 2020. This increase in allocations will allow the Saputi to better maximize its turbot harvesting capacity.

QC thanks the other Nunavut turbot allocation holders for working together to resolve some of the imbalance in the 0A/0B turbot allocations received by QC. The agreement is for two years and will be re-evaluated in the next full call for applications taking place in 2020 for implementation in the 2021 fishery.

Inshore Fishery Research and Development

This past year, the Fisheries Division continued its commitment to research and develop the inshore fishery in the Qikiqtani region.

Research Vessel: In 2018/19

funding was secured through various Federal and Territorial agencies and departments, leveraged with funding from QC, to design and construct a \$2.5 million multi-purpose research vessel. This vessel will work with the communities to do baseline research and surveys for the inshore sector.

The contract was awarded in late 2018/19 for the construction of the vessel which will commence in June 2019, with anticipated completion in late fall 2019. The vessel will be ready to start research in the Qikiqtani inshore region as soon as the ice conditions allow 2020.



Industrial Research Chair in Nunavut inshore fisheries: QC Fisheries has been working with the Marine Institute of Memorial University in St John's Newfoundland to establish a Nunavut inshore fishery research program. QC will work with the Qikiqtani communities to prioritize the inshore community projects.

Community Support

QC Fisheries Division is committed to working with Qikiqtani communities and supporting community and regional projects both through financial contributions and in-kind expertise.

Looking Forward

In 2019/20 QC will initiate another round of community tours across the Qikiqtani region to review and update the needs and priorities of the communities.

In 2019/20 QC will host a Qikiqtani region community Inshore Fishery Forum. This forum will bring in two representatives from each of the communities in the Qikiqtani region: one from the Hamlet and one from the Hunters and Trappers Association. The focus will be on the needs of the communities. Guest speakers from other Indigenous jurisdictions will participate in the event to provide insight in what they have done in their community and fishery economic development.

QC looks forward to an increased focus on the development of the inshore fishery development in the Qikiqtani communities, with special emphasis on the four Hunters and Trappers Associations from the communities of Cape Dorset, Hall Beach, Igloolik and Sanikiluag through the Qikigtani Fisheries Alliance.

QIKIQTAALUK FISHERIES CORPORATION ACTIVITY REPORT

Qikiqtaaluk Fisheries Corporation (QFC) is a wholly-owned subsidiary of QC. The company is a major participant in the Canadian shellfish and groundfish industries. QFC harvests shrimp and turbot quotas from QC, Unaaq Fisheries Inc., and from other Nunavut and southern quota holders.

MISSION:

To harvest QC fishing allocations through its wholly-owned vessel, a multi-species factory freezer vessel.

This past year saw significant changes for the company. QC is now the sole shareholder of QFC which meant changes to the administration and headquarters for the company. This is an exciting milestone for QFC. QFC has started rebranding and preparing marketing that showcases Nunavut. With 100 percent Inuit Ownership QFC can now place more focus on their commitment to maximizing Inuit employment.

QFC owns and operates a 76-meter multi species factory freezer vessel, the Saputi. Each trip has 26 to 29 crew members aboard the vessel depending on the length of trip and what species they are harvesting. The crew consists of a captain, mates, engineers, cooks, trawl and deck hands, factory supervisors and workers, a fishery observer and Japanese technician.

Company Employee Expansion

QFC has employees in Iqaluit (headquarters) and Newfoundland (satellite office). With the company now being fully owned by QC, new positions were created to facilitate the transition and continue the successful operations of the Saputi and marketing its production.



Turbot harvests 2018/19:

QC harvested 1,439 tonnes of turbot overall with 10.74 percent of overall Nunavut turbot allocations. While this is down considerably from its harvest in earlier years, QC will be harvesting an increase to 19 percent of Nunavut's turbot allocation in 2019 and in 2020.

Since 2010, on average, 49 percent of all turbot harvested by QC on the Saputi has come from leasing quota from other Nunavut and non-Nunavut allocation holders. This shows the imbalance in turbot quotas to QC versus other Nunavut turbot allocation holders through the previous NWMB Access and Allocation process. The Saputi has the capacity to harvest significantly more of the turbot quotas in the 0A/0B fishing zones administered by the NWMB. The changes to the Allocation Policy should ensure the Saputi can harvest more turbot in future years.



Turbot Harvested

Shrimp harvests 2018/19:

In 2018/19 QC's overall shrimp allocations (including QFC and Unaaq portion) increased by 164 tonnes over its 2017/18 quotas. During the 2018/19 year the QC portion of the Unaaq shrimp quotas were harvested by Clearwater Seafoods Limited Partnership (CSLP), however effective 2019/20 these allocations will be harvested on the Saputi.



Over the years there has been a significant difference the amount of quota sourced through DFO/NWMB and through lease. The amount of shrimp quota being sourced through DFO/ NWMB is remaining relatively consistent over the years while the amount of quota obtained through lease is decreasing.






Inuit Employment

Throughout 2018/19 the Saputi had an overall average of 36.6 percent Inuit crew. The percentage of Inuit working in the factory was 93.7. The combined factory and deck crew had a 66.6 percent Inuit employment rate.

2018/2019 hit the highest average of Inuit on each trip in the last five years and made a decade high record. The average number of Inuit on the Saputi has been steadily increasing over the last five years.

Looking Forward

In 2019 and beyond, QC will work with QFC to focus on streamlining the operations of QFC to maximize the benefits from the operations to Nunavummiut.

In 2019/20 QFC will be constructing a 4,000 square foot facility (office and warehouse building) in St. John's, Newfoundland. This facility will have office staff for QFC's operations staff and will have storage space to store its fishing gear and equipment. It is anticipated construction will break ground in June 2019 with occupancy in January 2020.



Turbot Trends

The turbot markets in 2018 was stable and strong. We expect demand for QC turbot production to be firm for following reasons:

- Worldwide supply of turbot has been stable over the past 10 years.
- Increased European demand for Canadian turbot.
- Saputi recognized as one of the top-quality brands in the market.
- Inventories at the beginning of the year were at a manageable level.
- Japanese yen is improving against the US dollar.

Shrimp Trends

Market returns for cooked shell-on shrimp were very good until later in the year at which time it started to go through a transition period, with downward pressure on pricing. We do not see any major shifts in the market for Canadian shell-on shrimp production in 2019 for the following reasons:

- China remains the major market for cooked shell-on product. While this market has been under price pressure from our competitors, market prices should stabilize.
- The markets for industrial shrimp are mainly for the processors in Scandinavia, however more of the Canadian production will go to shrimp peeling plants in Newfoundland and Labrador and in Quebec.
- The Japanese market for raw shrimp has been difficult with average pricing per kilo going from a high of almost \$7.50 USD in 2017 to less than \$5.00 USD in 2018. However, we expect the demand for raw shrimp to increase in 2019.

Inuit Employment

QFC will continue to maximize Inuit crewing not just in the factory positions but in managerial and technical positions both on the Saputi and in the offices.

This year also had a change in management for the Baffin Gas Bar with the departure of our General Manager in January. We welcomed Jackie Ropson as the new Manager who was promoted to take on this role.

Improved Customer Service

In our continued efforts to serve the needs and desires of the local community, QRS focused on streamlining our inventory. We introduced more items that would appeal to our local hunters, such as toboggans, and an expanded the fishing and outdoor products.

In efforts to offer customers the best prices, QRS negotiated with our existing suppliers and sought new suppliers. We have been successful in acquiring a variety of venders from computers to food items.

The Qikigtaaluk Business Development Corporation (QBDC) was created to focus on economic development opportunities within each of the thirteen Qikigtani communities of Nunavut. To deliver this mandate QBDC supports the other QC wholly-owned subsidiaries and partner companies in seeking viable economic opportunities. QBDC strives to create a unique partnership model with each community and seeks direct and indirect investment opportunities to deliver essential infrastructure and innovative approaches to community economic and career development.

QBDC pursues infrastructure and programming that aligns with the priorities of QC and Group of Companies and QIA. QBDC endeavors to proactively align synergies and support discussions that promote advancement of projects for the Qikiqtani region.


2018/19 Highlights

Land and Infrastructure Development

Infrastructure development on the 16-hectare Inuit Owned Land (IOL) in Igaluit broke ground in 2018 with the first pile of the Aqsarniit Hotel and Conference Centre driven into the ground. This represents a momentous step towards a new face for Federal Road, and a new opportunity for QC.

The Igaluit land development is unique in that it encompasses a large portion of undeveloped municipal and Inuit-owned lands. This development area is located along Federal Road which is currently only serviced with water and sewer through trucked delivery. Notwithstanding the need, the City of Iqaluit's fiscal realities limit their ability to extend water and sewer pipes along Federal Road to support development of new lands.

QBDC and the City of Igaluit have advanced discussions of a new development approach for Nunavut. It allows for QC to construct the necessary sewer infrastructure to connect the IOL to the City sewer infrastructure and recover a portion of these costs as future City lands are connected. This may also allow for QC to be a private developer of the municipal lands located adjacent and north of the IOL.


The goal of the Igaluit land development project is to undertake development in a manner that promotes best value of land. The development of this land will open opportunities for economic and social infrastructure that is much needed in Igaluit.

An MOU between the City of Igaluit and QC was executed in August 2018 committing the City and QC to working towards a Development Agreement that includes a fair and equitable cost-sharing approach for the servicing

Cape Dorset Metals Management Pilot Project

In 2017 Qikiqtaaluk Corporation successfully secured funding from Polar Knowledge Canada to mitigate negative environmental impacts of the Cape Dorset metals dumpsite. The project approach was a collaboration among Qikiqtaaluk Corporation, the Municipality, and the Territorial Government. The intent was to demonstrate the benefits of an Inuit-led and Inuit-delivered project.

Fifty-nine percent of the Cape Dorset pilot project funding stayed in the community in the form of wages, equipment and materials. Six community members were hired, provided four days of classroom training and certifications and three weeks of hands-on-training before beginning their work at the metals dumpsite.

Furthermore, an additional forty percent of the initial funding was leveraged beyond the original funding envelope. This money was used to expand the scope of the project to include added benefits such as a community clean up.







The Cape Dorset pilot project made clear the benefits of a negotiated agreement between Territorial/Federal Governments and Inuit Organizations. The negotiated agreement supported an Inuit-led and Inuit-delivered project. This made possible an approach that prioritized local jobs for Inuit. The training and transferrable skills gained through these jobs instilled worker empowerment, and community pride.







To promote the uptake of the Cape Dorset metals management model across Nunavut a report on the lessons learned, and the unique delivery approach was prepared. This report was distributed to Nunavut Tunngavik Inc, Government of Nunavut, the other Regional Development Corporations and the Nunavut mayors.

QBDC also created a metals baling guideline that provides easy-to-use information on baling metal that applies to Nunavut dumpsites.

Clean Energy Initiatives

QBDC has supported QC in their clean energy initiatives for several years. This past year, QBDC supported NNC in preparing several funding applications for a number of clean energy projects and studies, and continued planning and assessing the viability of several projects.

Sanikiluag Wind Project

QBDC has been assessing the wind regime in Sanikiluaq and the viability for wind energy since 2017. Initial modelling has projected a 1MW wind farm has the potential to displace 50 percent of the community's diesel consumption used for electricity.

QBDC supported NNC in preparing and submitting federal government funding applications for a 1MW wind farm in Sanikiluaq. In September, the funding application was accepted to advance to the next phase of funding consideration. For the remainder of the fiscal year, the funding application went through a rigorous regulatory, technical and financial review.





IOL smart microgrid

The IOL Development in Igaluit is progressing as a clean energy development. In addition to highly energy efficient buildings, the development will pursue energy independence through a smart microgrid, renewable energy installations, combined heat and power primary power stations, and energy storage technology. It is anticipated the system will be scalable with components added as the IOL is developed.

QBDC supported NNC in preparing federal funding applications to advance the front-end engineering and design of the IOL smart microgrid. In September, the funding application was accepted to advance to the next phase of funding consideration. For the remainder of the fiscal year, the funding application went through a rigorous regulatory, technical and financial review.


QBDC support for new community-driven initiatives

Grise Fiord Lodge & Visitors Centre

QBDC and the Hamlet of Grise Fiord have identified the need for accommodations and a cultural centre in Grise Ford. This need stems from the increased attention to Arctic tourism and the need for improved hospitality service in Canada's most northernly community. QBDC responded to an expression of interest funding call from CanNor to advance a business case for a Grise Fiord lodge. QBDC will continue to seek funding and advance the necessary desktop studies, community conversations, and stakeholder engagements to be in a stateof-readiness for when a funding opportunity should become available.



advocating for a deep-sea port for many years. Various feasibility studies and assessments have been progressed and work undertaken to assess the viability of the infrastructure. In Winter 2018 the Federal Government released a proposal call under the National Trade Corridors Fund, Transport Canada. QBDC and the Hamlet of Qikigtarjuag both expended great efforts to collaboratively prepare a proposal to the fund. The Government of Nunavut, QC and the Hamlet all committed financial and in-kind contributions to the project to leverage the federal funding. While the proposal was unsuccessful, the selection committee indicated there may be future opportunities for such critical infrastructure as the Qikiqtarjuag deep-sea port. QBDC will continue to advocate for this critical infrastructure and support the Hamlet in their determination to advance this infrastructure for their community, and for Nunavut.

In 2006 QPI was created from the merge between Kakivak Development Corporation and Lot 521 Joint Ventures. Since, QPI has flourished in delivering its mandate of managing real estate holdings. QPI strives to create a healthy living and working environment for its tenants.

2018/19 Highlights

New Construction and Purchases

Commissioning Uqsuq Garage and Office Building

In March QPI opened the doors to the new Uqsuq garage and office building. QPI leases the building to Uqsuq Corporation, a QC jointventure company. The building has provided Uqsuq this much-needed office space. The new building has also provided improved space for parking and servicing their fuel trucks, storage and employee training space.

QPI worked with the QC Companies, QBDC and NCC Development, to plan, manage and construct the building. The building is located on Inuit Owned Land along Federal road.



To provide safe, secure, functional and attractive accommodations for our tenants



QPI is responsible for providing safe, functional and attractive accommodations, delivering on four key areas:

- 1. Administration of QC Group of Companies' residential housing units
- 2. Management, including leasing and custodial services, of QPI commercial properties
- 3. Operations and maintenance of commercial and housing units
- 4. Property development

In 2018/19, QPI expanded its real estate portfolio with the construction and ownership of the new Uqsuq garage and office building. Several new lease agreements were secured and signed, two new residential buildings were purchased and numerous investments were made in building improvements to many QPI assets.







Residential Housing Units:

QPI purchased and renovated house #927. The building is currently accommodating the construction crew for the Aqsarniit Hotel.

QPI purchased house #562. QPI is currently leasing it as a residential unit with the long-term plan for the building to accommodate a youth project.

Building Improvements

Every year QPI invests in upgrades and renovations to their properties. This year, the upgrades included:

- Building 2007 Sewage tank replacement and apartment renovations.
- Building 923 Freezer/cooler compressor motors relocated to alleviate freezing and mechanical air handling issues.
- Building 923 Fire alarm system upgrades completed to meet code requirements. •
- Building 1106 Paving completed after a three-year delay due to airport project.

To improve our tenant service, QPI contracted C&K Services for custodial service for three commercial properties. Issues and complaints from tenants have significantly reduced which has subsequently freed-up staff time to focus on other priorities.




Apprenticeships

QPI created two apprentice positions over the past year; one carpentry apprentice and one housing maintainer apprentice. The apprenticeship program is completed through the Nunavut Arctic College. Candidates for the apprentice program must first complete an apprentice entry exam before starting with QPI as an apprentice.

Over the course of the year, the candidate for the carpentry apprentice position was completing his course program with Nunavut Arctic College to prepare himself for the apprentice entry exam. We anticipate he will start in the position in the fall of 2019.

The Housing Maintainer apprentice, Mike Nester, completed all three levels of Nunavut Arctic College's housing maintainer program and now has journeyman housing maintainer status. He has already assisted in building a house while accumulating close to a decade's worth of carpentry and home maintenance experience.

Qikiqtani Industry Ltd. (QIL) was created to pursue projects and partnerships within the industrial sector in Nunavut. QIL's mandate is to provide customized and turnkey camp and logistic service solutions with a focus on maximizing Inuit participation. QIL pursues projects in collaboration with business partners either as lead contractor or sub-contractor. QIL also provides support to many of QC's other subsidiary companies, joint ventures and affiliates through providing skilled labourers, automotive and heavy equipment mechanic services, and rental of equipment.

QIL reassesses the Arctic market needs on an ongoing basis and responds accordingly by redirecting their services to meet current market demands. QIL was initially created to focus on providing support and services to project developers and companies in the Arctic mining and oil and gas sectors. The company has since expanded their services and has formed two divisions; the Human Resources Division and the Logistics Division.

- The Human Resources Divisions focuses on providing catering and housekeeping services for remote sites, as well as general recruitment and employment services to external projects.
- The Logistics Division offers varying logistics services such as snow clearing, mail delivery services, environmental remediation services, and professional moving and assembly services.

QIL continues to meet its contractual obligations with a focus on increasing Inuit employment

QIL Logistics

QIL continued to offer many services to local companies and government departments this year, including mail service contracts and ground transportation services as well as providing heavy equipment service and vehicle repairs of QC Group of Companies' fleet.

QIL remains the first choice for many companies for our logistical services in moving and local cartage. Our reputation of quality work is shown through our long-term customer client relationships and retention.

QIL continues to offer affordable commercial and residential snow clearing, sanding and snow removal services. QIL had been awarded a two-year snow clearing contract by the Government of Nunavut and currently provides services to QPI's and NCC's properties.

While this has been a year of stabilization, throughout this fiscal year QIL took steps towards expanding our existing successes. QIL is well-managed and fully staffed with qualified and professional employees. QIL will continue to support our employees with training to meet our ever-growing needs.


QIL purchased a fleet of equipment to prepare for the construction of the Aqsarniit Hotel. QIL will supply rental of this equipment to the project. This sound financial decision will promote risk averse growth and expansion of our fleet.

Mary River Catering and Housekeeping Contract

QIL provides catering and housekeeping services to the Mary River Mine site, serving close to 1000 people on site daily at the peak of the 2018/19 season. This contract has allowed us to hire over 300 employees, with the majority of the employees coming from the communities in the Qikiqtani region. On-the-job training is provided on site and classroom training off site. In 2018/19, two of our Inuit employees were certified through the Nunavut Arctic College as camp cooks. Eight employees have received food safe training and nine employees have received first aid training.


